PETITIONER'S MOTION TO CONSOLIDATE

SEEKING DISCRETIONARY REVIEW OF A DECISION OF THE
SECOND DISTRICT COURT OF APPEAL

PETITIONER, Capital Wealth Advisors, Inc., hereby files this Motion to Consolidate in accordance with Fla. R. App. P. 9.300 and states as follows:

1. On October 21, 2021, the Second District Court of Appeal rendered an opinion in Case No. 2D20-2446, which is captioned *Capital Wealth Advisors, LLC v. Capital Wealth Advisors, Inc., William N. Beynon and Blaine M. Ferguson*.

2. The opinion has a single ruling that affects all the parties.

3. On April 14, 2022, Petitioner, Capital Wealth Advisors, Inc., filed its Notice to Invoke Discretionary Jurisdiction.

4. On April 14, 2022, William N. Beynon and Blaine M. Ferguson filed their Notice to Invoke Discretionary Jurisdiction.

5. Acknowledgment letters were sent on April 19, 2022, opening the above-captioned case along with Case No. SC22-498.

6. The issues in the two cases are the same, and the record on appeal will be identical.

7. Since both appeals stem from the same opinion and will have the same record, it is most efficient to consolidate the two cases.

8. Undersigned counsel has consulted with opposing counsel and is authorized to represent that opposing counsel has no objection.

WHEREFORE, Petitioner, Capital Wealth Advisors, Inc., respectfully requests that the Court: (1) consolidate Case Nos. SC22-496 and SC22-498, and (2) grant any further relief the Court deems just and appropriate.
