**MOTION FOR CLARIFICATION OR, IN THE ALTERNATIVE,
MOTION FOR EXTENSION OF TIME**

Plaintiffs/Appellants/Cross-Appellees/Petitioners Ralph Mawardi and Limor Mawardi (“Petitioners”), by and through undersigned, request clarification as to whether the Petitioners’ jurisdictional brief is due prior to their response to the Florida Supreme Court’s November 7, 2023 order to show cause (“Order”).

The instant motion is being filed in abundance of caution following the Order, which requires Petitioner to file a response or make certain elections as to jurisdiction on or before November 22, 2023.
