GRIEVANCE COMMITTEE'S FINDING OF NON-COMPLIANCE, FAILURE TO COMPLY WITH A SUBPOENA DUCES TECUM, AND CONTEMPT

On November 30, 2023, pursuant to Rule 3-7.11(f), Rules Regulating The Florida Bar, the Eleventh Judicial Circuit Grievance Committee G considered whether to issue a Finding of Non-Compliance, Failure to Comply with a Subpoena Duces Tecum, and Finding of Contempt and made the following findings:

1. On August 18, 2022, respondent was served with a subpoena duces tecum and instructed to provide the responsive documents by September 7, 2022.

2. After three requests for extensions of time, respondent provided a partial production on October 21, 2022.

ехнівіт **1** 3. The bar's Staff Auditor attempted to use the information provided to conduct his review of the trust account. However, from the minimal records provided the auditor was unable to determine if the funds were properly disbursed in complainant's matter, and/or whether complainant is the beneficial owner of any of the funds remaining in the account, from which additional disbursements for complainant's benefit are still pending. A copy of the Staff Auditor's Affidavit, with exhibits, is attached hereto as Exhibit "A."

4. On May 12, 2023, respondent was given notice that the Eleventh Judicial Circuit would hold a hearing on the issue of non-compliance with a trust account subpoena. A copy of the letter dated May 12, 2023, without enclosures, is attached hereto as Exhibit "B."

5. On May 30, 2023, respondent mailed a supplemental production. However, the supplemental production still lacked the required records necessary for the Staff Auditor to determine the beneficial owners of the funds remaining in the trust account.

6. On June 8, 2023, the Staff Auditor emailed specific instructions to respondent concerning the records necessary to complete his review, and provided sufficient time for respondent to re-create the records if necessary. The deadline for respondent to submit the missing

documentation was June 28, 2023, subsequently extended to July 5, 2023. A copy of the Staff Auditor's Email is attached hereto as Exhibit "C."

7. On July 8, 2023, respondent emailed the Staff Auditor to explain that he could not meet the July 5, 2023, deadline because his computer containing the requested records was inoperable and under repair. Respondent submitted some additional hand written records, and promised the requested records would be forthcoming pending the repair.

8. On August 25, 2023, when the promised records were still not received, the Staff Auditor sent an email reminding respondent of his obligation to submit the missing documentation. The Staff Auditor's Email is attached hereto as Exhibit "D."

9. Having received no additional responsive documentation from respondent, the Staff Auditor notified bar counsel on November 3, 2023 that respondent remained non-compliant with the subpoena duces tecum that was originally served on August 18, 2022.

10. On November 14, 2023, the Bar served respondent with Notice that the Eleventh Judicial Circuit Grievance Committee G would hold a hearing to determine whether Good Cause existed for respondent's noncompliance with a trust account subpoena. A copy of the letter dated November 14, 2023, without enclosures, is attached hereto as Exhibit "E."

11. On November 20, 2023, respondent submitted a response to the grievance committee, which still lacked the complete trust accounting records required by Rule 5-1.2 of the Rules Regulating Trust Accounts, and which was not a complete response to the subpoena duces tecum.

12. As of the date of this notice, Respondent has failed to fully respond to the subpoena duces tecum served on August 18, 2022.

13. On November 30, 2023, The Grievance Committee found that respondent failed to establish good cause for failing to respond to the subpoena duces tecum, and that the non-compliance was willful.

14. The Grievance Committee found respondent to be in contempt and requested The Florida Bar to file a Petition for Contempt and Order to Show Cause with the Supreme Court.

AFFIDAVIT OF PATRICK M. DOUGHERTY

STATE OF FLORIDA COUNTY OF HILLSBOROUGH

Patrick M. Dougherty says:

- Affiant is a Senior Auditor for the Lawyer Regulation of The Florida Bar, and is a Certified Public Accountant licensed and in good standing in the State of Florida.
- 2. This affidavit is based on my personal knowledge and review, and is in reference to the Respondent, Albert E. Moon and Florida Bar File 2022-70,212(11G).
- 3. For purposes of rendering my opinion as to the Respondent's compliance with The Florida Bar's inquiries and to produce all subpoenaed trust account records, I have considered and reviewed Florida Bar Rule 5-1.2, The Florida Bar's subpoena and inquiries to the Respondent, and the Respondent's responses to the subpoena and inquiries.
- 4. The Bar's investigation ensued pursuant to a complaint made by Dr. Robert Frankl. The Complainant alleged that the Respondent was disbursing settlement funds that he received on behalf of the Complainant without his authorization and without a signed closing statement. **See Composite Exhibit 1.**

- 5. After reviewing several documents provided by the Respondent and the Complainant, the Bar issued two subpoenas for trust account information.
- 6. One was issued to First Horizon Bank requesting copies of the following documents for the Respondent's trust account ending in 0852 and the cost account ending in 9537 for the period August 1, 2019, through July 31, 2022. See

Exhibit 2.

- a. Copies of all bank statements.
- b. Copies of all cancelled checks.
- c. Copies of all deposit slips.
- d. Copies of all deposited items.
- e. Copies of all supporting documentation for all incoming and outgoing wire transfers.
- f. Copies of all supporting documentation for any inter-account transfers.
- 7. First Horizon Bank fully responded to the subpoena that was issued.
- The second was issued to the Respondent requesting the following documents for the trust account ending in 0852 for the period August 1, 2019, through July 31, 2022. See Exhibit 3.
 - a. List of the bank, name on the account and account number for all bank accounts.

- b. Original or clearly legible copies of deposit slips if the copies include all data on the original and, in the case of currency and coin, an additional cash receipts book, clearly identifying the date and source of all trust funds received and the client or matter for which the funds were received.
- c. Cancelled checks for all trust accounts, all of which must be numbered consecutively, include all endorsements and all other data and tracking information and clearly identify the client or case by number or name in the memo area of the check.
- d. Other documentary support for all disbursements and transfers from all trust accounts including records of all electronic transfers from client trust accounts, including the name of the person authorizing the transfer, the name of the recipient, confirmation from the banking institution confirming the number of the trust account from which the money is withdrawn and the date and time the transfer was completed.
- e. Original or clearly legible digital copies of all record regarding wire transfers into or out of the trust account, which at a minimum must include the receiving and sending institution's ABA routing numbers and names, and the receiving and sending account holder's name, address and account number. If the receiving financial institution process through a correspondent or intermediary bank, then the records must include the ABA routing number

and name for the intermediary bank. The wire transfer information must also include the name of the client or matter for which the funds were transferred or received, and the purpose of the wire transfer, (eg., "payment on invoice 1234" or John Doe closing").

- f. Journal of disbursements and receipts for all trust accounts, including columns for receipts, disbursements, transfers and the account balance. The journal should at least contain the identification of the client or matter for which the funds were received, disbursed, or transferred, the check number for all disbursements and the reason for which all trust funds were received, disbursed, or transferred.
- g. A separate file or ledger with an individual card or page for each client matter, showing all individual receipts, disbursements, transfers and any unexpended balance. The file or ledger should contain the identification of the client or matter for which the trust funds were received, disbursed, or transferred, the date on which all trust funds were received, disbursed, or transferred, the check number for all disbursements and the reason for which all trust funds were received, disbursed, or transferred.
- h. Monthly bank or savings and loan association statements for all months for all trust accounts.

- i. Monthly bank reconciliations for all monthly bank or savings and loan association account statements, disclosing the balance per bank, deposits in transit, outstanding checks identified by date and check number, and any other items necessary to reconcile the balance per bank with the balance per the checkbook and the cash receipts and disbursements journal.
- j. Comparison between the total of the reconciled balances of all trust accounts and the total of the trust ledger cards or pages, together with specific descriptions of any differences between the two total and the reasons for these differences.
- 9. The second subpoena also requested the following documents for the cost account ending in 9537 for the period August 1, 2019, through July 31, 2022.
 - a. Copies of all bank statements.
 - b. Copies of all cancelled checks.
- 10. The documents requested in the subpoena to the Respondent were due on September 7, 2022.
- 11. On August 30, 2022, the Respondent requested a 30-day extension to respond to the subpoena. Respondent provided a partial response with exhibits on September 7, 2022, and an extension was granted to provide the remaining information by October 7, 2022. See Exhibit 4.
- 12. On October 7, 2022, the Respondent requested an additional 7-day extension to respond to the subpoena, which was granted. See Exhibit 5. 5

- 13. On October 14, 2022, the Respondent requested another 7-day extension to respond to the subpoena, which was also granted. See Exhibit 6.
- 14. After reviewing all of the documents provided by the Respondent in response to the subpoena as well as documents that were previously provided, I found that the Respondent has not complied with the Florida Bar's subpoena, in that the Respondent has still failed to provide the following information for the trust account ending in 0852.
 - a. The Respondent did not provide all of the requested deposit slips. Some deposit receipts were provided but not for all of the deposits that were made during the requested period.
 - b. The Respondent did not provide a receipts and disbursements journal that was requested.
 - c. The Respondent only provided two client ledgers. One of the ledgers was a ledger for the Complainant. See Composite Exhibit 7.
 - d. The Respondent only provided two of the monthly bank reconciliations that were requested.
 - e. The Respondent did not provide any of the monthly comparisons that were requested.
- 15. When the Respondent provided his response to the subpoena on October 21, 2022, he stated that he had requested additional materials from his former

assistant in North Carolina and they would be forwarded on receipt. See Exhibit 8.

- 16. On December 28, 2022, I emailed the Respondent to ask if he received any additional information from his assistant. The Respondent never replied to that email. See Exhibit 9.
- 17. I attempted to use the information provided to compile trust account records to determine if the Complainant's funds were still in the trust account but was unable to do so with the information provided.

Dear Dr Frankl,

I am in receipt of your e-mail and apologize for not contacting you sooner. Unfortunately I have been without a secretary for four weeks as her nephew has been in Jackson in a coma and she went to Miami from her home in NC.

In any case your case status is as follows:

MISAPPROPRIATION OF TRUST FUNDS

COMPLAINT #1 OF ALBERT MOON ESQ. TAKING FUNDS WITHOUT MY AUTHORIZATION AND DEPOSITING. Albert Moon represented me in a law suit and accident of March 2/12 which I settled on August 15/2019. I gave specific instructions to Mr. Moon not to deposit the check from Geico until I sign the check (endorse) and review the closing statement for accuracy (EXHIBIT 1) which was emailed to Mr. Moon. Further I did not sign the RELEASE for Geico for creating the check. Mr. Moon managed to get the check from Geico without my release and deposited it in his trust account contrary to my instructions to him. No release was signed by me as I expected the check to remain with Geico until I am satisfied with the reductions all providers will give me. Mr. Moon received my email on August 19/19. The case settled on August 15/2019 being a friday. (EXFIBIT 1)

COMPLAINT #2 OF ALBERT MOON ESQ. TAKING FUNDS FROM TRUST ACCOUNT MITHOUT MY AUTHORIZATION

Mr. Moon is already spending settlement trust account funds without my authorization or closing statement. He seems to think the settlement trust account is his operating account or he is treating it the same. Mr. Moon in error sends me a check for \$576.00 with a cover letter hand written made out to Florida Médiation Group. I return the check to Mr. Moon on Nov 13/2020. Trust account funds must not be used as an operating account or money spent without a court order or authorization by the client and closing statement. EXHIBIT # 2,3,4.5.

COMPLAINT #3 OF ALBERT MOON ESQ.

PART THREE:

I did not authorize Mr. Moon to settle an attorney fee lien with the prior attorney Mr. Rodman. Mr. Moon accepted a \$6,000.00 payment from Mr. Rodman which came from a trust account of Mr. Rodman which I did not authorize nor sign a closing statement for Mr. Rodman Esq. to release those funds and Mr. Moon was aware of that. Mr. Moon enclosed a closing statement for attorney Rodman for me to sign. I did not sign the closing statement after the fact funds had been taken from the trust account and received by Mr. Moon. I do not agree with that closing statement and for Mr. Moon to receive those funds from the Rodman trust account which I did not authorize to be released. EXHIBITS: 6,7.

COMPLAINT #4 OF ALBEPT MOON ESQ. Failure to provide a closing statement for Robert Frankl It has been two and quarter years since settlement of my case and my attorney ignores me for months to keep me informed about the disbursement of funds, closing statement, the status of the case but assures me he has the funds in his trust account which I did not even authorize. When I spoke to Mr. Moon today by phone he advised me his secretary had been out working remotely and will be working on the closing statement. This explanation I heard from him previously months ago with no end to it. <u>As of Nov 1/2021</u> He related to me that he sent to Mr. Rodman the first attorney \$6,000.00 or he received \$6,000.00 from Mr. Rodman he is not sure; however, Mr. Rodman is waiving his costs. based on an email he received from attorney Rodman. I asked him to email a cony of that email from Mr. Ronald Rodman. He advised me he would send it over.I received nothing.

COMPLAINT #5 OF ALBERT MOON FAILURE TO RESPOND TO HUMANA REGARDING SUBROGATION CLAIM. A letter from Albert Moon advising me on Dec 30/2020 he is trying to resolve all medical liens and will do a final closing statement. (EXHIBIT 6). On October 16/2021 I receive a letter from HUMANA advising me they sent Mr. Moon written requests for information on several occasions regarding their subrogation claim but they receive no response from Mr. Moon.Humana asks3 me to keep them current on the case. I snoke to Humana and advised them to provide me with all copies of the CMS 1500 claim forms from nroviders to divide what is accident related and what is not. Is this not Mr. Moon's job?(EXHIBIT 8)

COMPLAINT #6 OF ALBERT MOON

weeker directs

AT trial Judge Carlos Rodriguez Mr. Albert Moon not to mention anything about the defendant Alan Matthews passing away about two weeks ago as it would be prejudicial. Mr. Moon advises the jury that Alan Matthews did not even bother coming to court. Mr. Kasen the lawyer for Geico wants a mistrial. The judge simplywants to rule on this at the end of the trial. I feel this is creating more problems for me should the judge grant a mistrial or Geico anneals the case if not pleased with the outcome. Due to error by Mr. Moon I may take the full financial responsibility of a new trial, unless I settle the case prior to verdict.

COMPLAINT OF ALBERT MOON#7

In the hallway outside the courtroom Mr. Moon pressures me to settle the case giving me all the advantages: of settling the case and not having an excess verdict as I would have to hire an appeals lawyer at my exnense and the case would end when I would be eighty-five years old (8 years later). Previously Mr. Moon advises me he would take 30% of the settlement not 40% as an insentive. He then tells me the Providers will now take 50% to 75% off their fees but does not give mer any dollar figures. He does not even give me any dollar amount of what their fees are.

As Mr. Moon is a legal provider he is now willing to take off his fee 50% at least. So going from 40% of the settlement amount he will take 20% of the settlement amount or jury verdict. At this point he does not even give me the actual amount owing the health care providers or their reductions specifically. In the meantime Mr. Moon has all the money and has no idea when he will release any funds to me. This is never ending.

COMPLAINT OF ALBERT MOON #8 FAILURE TO REPRESENT ME AT THE HEARING OF FEB 2/2020. On March 20/2017 Mr. Ronald Rodman files motion to withdraw and requests fees and costs Exhibit 9, Judge Carlos Rodriguez order granting motion to withdraw and retain a lien in this matter for costs incurred up to the date of the order. (<u>DID NOT ALLOW FEES</u>). (EXHIBIT 10) The date of this ORDER was March 20/2017.

Knowing that I am not responsible for FEES to Mr. Ronald Rodman I agree to settle the law suit on August 15/2019 unon signing a release. at a later date.

Ronald Rodman and his law office Friedman, Rodman and Frank files a motion for FEES AND COSTS. The prior order on March 20/2017 only allowed COSTS NOT FEES.

Albert Moon at the current hearing of Feb 4/2020 failed to say anything about the prior order by Judge Rodrigeus only allowing costs. As a matter of fact Mr. Moon said absolutely nothing at that Feb. 4/2020 hearing. He only appeared physically with me giving me no representation at all. I could not believe that a lawyer could appear for a client at a hearing and say nothing. The judge ruled for Attorney Lien (Fees) and costs. The prior order of March 20/2017 is still a standing court order which had not been amended nor vacated. EXHIBIT 11. Mr. Moon also failed to take the deposition of Mr. Rodman nor set down an evidentiary hearing prior to the hearing of Feb 4, 2020 dealing with fees and costs.
