NOTICE TO INVOKE DISCRETIONARY JURISDICTION

Notice is given that Michael J. Williams (Defendant/Appellee/Petitioner), invokes the discretionary jurisdiction of the Supreme Court to review the March 17, 2016 decision of this Court, rendered April 14, 2016, when timely-filed motion for rehearing was denied.

The decision reversing Williams' dismissal expressly and directly conflicts with a decision of another district court of appeal on the same question of law. That is, whether an agreement is ambiguous as to personal liability of a corporate officer signing in a representative capacity for the signatory corporate entity because the agreement is headed by the individual's name as "of" the corporate entity and because the agreement refers to obligations under the contract performed by individuals, but does not contain any language subjecting the corporate officer
