The Attorney General respectfully requests that the Court allow her to participate in any oral argument that may be scheduled for this case. Additionally, the Attorney General requests that the Court accept both her comment and Request to Participate in Oral Argument as timely filed.

On December 7th, the Attorney General moved for a final fourteen-day extension of time to file comments. Florida Rule of Appellate Procedure 9.300(b) provides that “service of a motion shall toll the time schedule of any proceeding in the court until disposition of the motion.” This Court has not, to date, ruled on the Attorney General’s motion. And although the Court has previously granted extensions to file comments, those extension orders did not specifically address the time frame for filing a request to participate in oral argument.
