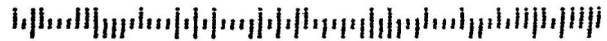



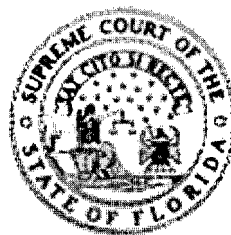
The above cases are hereby scheduled for oral argument at 9:00 a.m.,
