**THE FLORIDA BAR'S MOTION TO VOLUNTARILY DISMISS  
PETITION**

The Florida Bar (the bar) respectfully requests leave to voluntarily dismiss its petition in this case and states as follows:

The bar filed a petition to amend the Rules Regulating The Florida Bar, creating new chapter 23 to register online service providers, on December 12, 2019.

This Court scheduled oral argument for September 9, 2020, after receiving numerous comments.

This Court issued an order on August 13, 2020, removing the case from oral argument.

This Court issued an order on November 3, 2020, deferring consideration of this case until after the Court ruled in *The Florida Bar v. TIKD Services LLC*, Case No. SC18-149 and until after the Court received the final report of the Special Committee to Improve the Delivery of Legal Services.

This Court issued an order on March 2, 2022, scheduling the case for oral argument on April 6, 2022.

The bar filed a motion to request that this Court defer consideration of the matter until after this Court's receipt of the

Special Committee on Great Public Access to Legal Services, which was filed December 27, 2022.

This Court issued an order on July 21, 2023, directing the bar “to file a response to this order on or before August 7, 2023, stating whether this case should now be rescheduled for oral argument.”

The bar’s Executive Committee of The Florida Bar Board of Governors authorized filing this motion to dismiss.

The bar requests that this Court dismiss the petition in this case.
