**FINAL JUDGMENT IN FAVOR OF THIRD-PLAINTIFF GONZALO FERNANDEZ  
AGAINST THIRD-PARTY DEFENDANT ROBERTO SERVITJE-ACHUTEGUI**

THIS CAUSE having come before this Court by Jury Trial on April 22, 2024, for which a jury verdict was returned and entered on April 25, 2024, and the Court having heard oral arguments by counsel for the parties, having reviewed the evidence and the record, considered the Jury Verdict rendered on April 25, 2024, and the Court being fully advised in the premises, it is hereupon

**ORDERED** and **ADJUDGED** as follows:

1. That this Court has jurisdiction over the subject matter, and the parties.
2. On April 25, 2024, a Jury entered a verdict in Favor of Mr. Fernandez on Mr. Fernandez' Counterclaim for Tortious Interference with a Business Relationship, for an amount of \$101,623.68 in damages awarded to Mr. Fernandez.
3. That along with pre-judgment interest accruing from the date of injury, October 3, 2017, to the present in the amount of \$41,896.13, the total amount of the judgment is \$143,519.81 ("Total").

4. Pursuant to the jury's allocation of fault on its verdict, dated April 25, 2024, the amounts due from each Counterclaim Defendant are as follows:

a. ALTEX USA CORPORATION:	<u>50% of (Total)</u>	\$71,759.91
b. ROBERTO SERVITJE-ACHUTEGUI:	<u>25% of (Total)</u>	\$35,879.95
c. MAURICIO SERVITJE-LABARRERE:	<u>25% of (Total)</u>	\$35,879.95

5. That Third-Party Plaintiff, GONZALO FERNANDEZ, is due, awarded and entitled to Judgment in his favor and against ROBERTO SERVITJE-ACHUTEGUI, for the total sum of THIRTY-FIVE THOUSAND EIGHT HUNDRED SEVENTY-NINE DOLLARS AND NINETY-FIVE CENTS (\$35,879.95), for which let execution issue forthwith.

6. The current address of Third-Party Plaintiff GONZALO FERNANDEZ is 321 Palmwood Lane, Key Biscayne, FL 33149. The current/last known address of Third-Party Defendant ROBERTO SERVITJE-ACHUTEGUI is c/o St. Denis & Davey, P.A., 600 Brickell Avenue, Suite 1715, Miami, Florida 33131.

It is further ordered and adjudged that the judgment debtor, ROBERTO SERVITJE-ACHUTEGUI, shall complete under oath Florida Rule of Civil Procedure Form 1.977 (applicable Fact Information Sheet), including all required attachments, and serve it on the judgment creditor's attorney, within 30 days from the date of this judgment, unless the judgment is satisfied, or post-judgment discovery is stayed.

8. Jurisdiction of this case is retained to award attorney's fees and costs, including fees and costs associated with seeking entitlement to fees and costs, fees and costs incurred for determining the amounts of fees and costs, as well as any fees or costs associated with any appeals.
