**THIS CAUSE** came before the Court on Plaintiff/Garnishor, **OBSESSIONS IN TIME, INC.**'s ("Plaintiff" or "Garnishor") Motion for Entry of Final Judgment of Garnishment Against Garnishee, **JPMORGAN CHASE BANK, N.A.**, following the Court's Granting of said Motion. 3. The Court retains jurisdiction to compel Garnishee to comply with this Final Judgment Against Garnishee. Should Garnishee fail to pay this judgment as ordered herein, it may result in execution of the judgment, including garnishment.


