I am appealing the orders I have submitted as of this date for the following reasons:

At no time whatsoever, since 2018, was I ever told by any judge that I could file an indigent form and request an attorney to help with this, and I repeatedly stated I was disabled and uploaded a social security form showing that. Again in 2024, after I corrected the indigent form and filed this appeal, no action was taken by the lower tribunal, even after several queries, such that I had to voluntarily dismiss my case due to not being able to afford to pay. After that, the lower tribunal processed the indigent form.

October 24, 2023 Order:

The following document is is the most recent order in this case.

This order by Judge Bell withdraws her previous order that I fill out the financial form, so that I could pay \$50,000 in attorneys fees, or go to jail.

I filled out the form and posted it online because I didn't want to go to jail.

I didn't want to go to jail because if I was in jail I wouldn't be able to go to my cancer treatments.

Judge Bell ignored my motions to dismiss the case.

However Judge Bell did rule on my motion that she recuse herself from the case because she previously worked alongside Judge Kastrenakes, "Facebook friend" of Sachs Sax Caplan attorney Prudenti, and she ruled that she was

remaining on the case.


**ORDER CANCELLING SHOW CAUSE HEARING SCHEDULED FOR OCTOBER
